The following is the Annual Progress Report for 2015-2016 school year.

### **How are our students doing in Reading, Math and Science?**

#### **Reading Goal**

For the 2015-16 school year, 73% of students will achieve their Reading growth targets as identified by the fall to spring Measures of Academic Progress (MAP) testing.

#### **Did we meet the Goal?**

**YES**

#### **Data/Results to support:**

Our 2015-16 Measures of Academic Progress (MAP) testing shows that 113/151 students or 75% of the students were able to achieve their Reading growth targets.

#### **Reading Goal for 2016-2017:**

In the Spring of 2017, 70% of students in grades 1-6 will be at or above benchmark on the Fast Adaptive aReading assessment.

#### **Math Goal**

For the 2015-2016 school year, 71% of students will achieve their Math growth targets as identified by the fall to spring Measures of Academic Progress (MAP) testing.

#### **Did we meet the Goal?**

**YES**

#### **Data/Results to support:**

Our 2015-16 Measures of Academic Progress (MAP) testing shows that 124/151 students or 82% of the students were able to achieve their Math growth targets.

#### **Math Goal for 2016-2017:**

For the 2016-17 school year, **60%** of students will achieve their growth targets as identified by the fall to spring iReady Math Assessment.

This is a new goal, using the result of the iReady Math Assessment. Recommendation from iReady was 60% for the first year of using this assessment.

### **Science Goal**

For the 2015-16 school year, 66% of students will achieve their Science growth targets as identified by the fall to spring Measures of Academic Progress (MAP) testing.

**Did we meet the Goal?** YES

### **Data/Results to support:**

Our 2015-16 Measures of Academic Progress (MAP) testing shows that 35/48 students or 73% of the students were able to achieve their Science growth targets.

### **Science Goal for 2016-2017:**

For the 2016-17 school year, **73%** of students will achieve their growth targets as identified by the fall to spring Measures of Academic Progress (MAP) testing.

### **Early Intervention Goal**

For the 2015-2016 school year, 80% of the Kindergarten and 1st Grade will be at or above benchmark on the spring composite score on the TIER Assessment

**Did we meet the Goal?** NO

### **Data/Results to support:**

Our 2015-16 Spring aReading Composite Score, a combined 21/31 or 68% of Kindergarten and First Grade students scored at or above benchmarks as demonstrated on the spring aReading assessment.

### **Early Intervention Goal for 2016-2017:**

For the 2016-17 school year, 80% of Kindergarten and First Grade students will be at or above benchmark as demonstrated on the spring aReading assessment.

### **School Culture/Climate – Bullying/Harassment Goal**

#### **Bullying/Harassment Goal for 2015-2016:**

For the 2015-2016 school year, in grades PK – 12 to have fewer than 3 official reports to the administration of a bullying/harassment incident.

**Did we meet the Goal?** YES

### **Data/Results to support:**

For the 2015-16 school year, one official report was made to the administration of a bullying/harassment incident.

#### **Bullying/Harassment Goal for 2016-17:**

For the 2016-2017 school year, in grades PK – 12 to have fewer than 3 official reports to the administration of a bullying/harassment incident.
